

PASSENGER EXPENSES EN ROUTE

- (A) WHEN REQUESTED BY A PASSENGER, VIRGIN ATLANTIC WILL BEAR THE COST OF EN ROUTE EXPENSES FOR HOTEL EXPENSES, CHARGES FOR GROUND TRANSFER SERVICES (EXCEPT AS PROVIDED IN RULE 30 (GROUND TRANSFERS) AND MEALS, OTHER THAN THOSE SERVED ONBOARD) SUBJECT TO THE CONDITIONS DETAILED IN THIS TARIFF
- (1) THIS RULE IS ONLY APPLICABLE FOR ON-LINE VIRGIN ATLANTIC TO VIRGIN ATLANTIC TRANSFERS. VIRGIN ATLANTIC ARE NON-SIGNATORIES TO IATA RECOMMENDED PRACTICE 1775 AND WILL THEREFORE NOT ABSORB ANY PASSENGER EXPENSES FOR INTERLINE TRANSFERS
 - (2) PASSENGERS MUST BE TICKETED FOR ONWARD CONFIRMED TRAVEL ON VIRGIN ATLANTIC SERVICES PRIOR TO ARRIVAL AT THE TRANSFER POINT
 - (3) EXPENSES FOR ALCOHOLIC BEVERAGES (OTHER THAN THOSE OFFERED FREE ONBOARD) OR TELEPHONE CALLS WILL NOT BE ABSORBED
 - (4) TRANSFERS BETWEEN LGW AND LHR WILL BE PROVIDED BY LIMO SERVICE FOR UPPER CLASS PASSENGERS BOOKED IN J/C/D/I CLASSES AND APPLICABLE COACH SERVICE FOR ALL OTHER PASSENGERS ELIGIBLE FOR TRANSFERS UNDER THIS RULE
 - (5) PASSENGERS MUST BE BOOKED ON THE FIRST AVAILABLE CONNECTION AFTER ARRIVAL AT TRANSFER POINT
 - (6) PASSENGER TRAVELLING BETWEEN USA AND A SOUTHERN AFRICAN REGIONAL POINT (ANY POINT IN BOTSWANA, NAMIBIA, ZIMBABWE, SOUTH AFRICA) WILL BE ENTITLED TO EN ROUTE EXPENSES FOR TRANSFERS IN LON ONLY
 - (7) HOTEL EXPENSES WILL ONLY BE ABSORBED FOR TRANSFERS OVER 8 HOURS. FOR TRANSFERS OF UNDER 8 HOURS, MEALS (EXCEPT THOSE OFFERED ONBOARD FREE OF CHARGE) AND GROUND TRANSPORTATION (AS DETAILED IN POINT (4)) WILL BE ABSORBED
 - (8) EXPENSES SHALL NOT BE ASSUMED BEYOND THE DEPARTURE OF THE NEXT SCHEDULED CONNECTION OF THE CARRIER IN THE CLASS OF SERVICE FOR WHICH THE PASSENGER IS TICKETED AND ON WHICH SPACE IS AVAILABLE, OR BEYOND 24 HOURS AFTER ARRIVAL AT THE CONNECTING POINT WHICHEVER IS EARLIER; WHERE THERE IS NO ONWARD FLIGHT OF THE CARRIER SCHEDULED TO DEPART WITHIN SUCH 24-HOUR PERIOD SUCH EXPENSES MAY BE ABSORBED ONLY FOR 24 HOURS AFTER ARRIVAL AT THE CONNECTING POINT AND WHERE THERE IS AN ONWARD FLIGHT OF THE CARRIER SCHEDULED TO DEPART WITHIN SUCH 24 HOUR PERIOD BUT THE PASSENGER DOES NOT DEPART FROM SUCH CONNECTING POINT WITHIN 24 HOURS, NO SUCH EXPENSES WILL BE ABSORBED
 - (9) REPRESENTATIVES WILL MAKE APPLICATIONS ON THE PASSENGERS BEHALF FOR HOTEL RESERVATIONS, HOWEVER THE AVAILABILITY THEREOF IS NOT GUARANTEED. ALL EXPENSES INCURRED BY CARRIER OR ITS REPRESENTATIVES IN ARRANGING, OR ATTEMPTING TO ARRANGE FOR RESERVATIONS WILL BE CHARGEABLE TO PASSENGERS EXCEPT AS OTHERWISE PROVIDED IN THIS TARIFF
- (B) APPLICABLE FARES
EN ROUTE EXPENSES WILL ONLY BE ABSORBED AS DETAILED ABOVE FOR PASSENGERS WHO HAVE PURCHASED THE FOLLOWING FULL AND UNRESTRICTED FARES BOOKABLE IN J/C/D/I/Z W/S/Y OR B CLASSES:
